NOTIFICATION

This is to notify to all Faculty members/Students /Researchers/ Non-Teaching staffs/ Outsourced Staffs of the Institute that in addition to earlier notification issued vide No. NITD/Estt./CoVID-19/2021/13 dated 06/10/2021 regarding the restrictions imposed by Government of West Bengal to contain and combat the spread of CoVID-19 Pandemic vide their order No. 753/X-ISS/2M-22/2020 dated 30/09/2021, further notification have been released by Government of West Bengal vide no. 753/XX-ISS/2M-22/2020 dated 15/01/2022 regarding revised restriction measures imposed within the state of W.B up to 31st Jan, 2022.

Accordingly, in-order to ensure the safety of Faculty members/Students / Researchers/ Non-Teaching staffs and Outsourced Staffs of Institute, the competent authority has arrived at the following decisions:

1. The academic activities i.e. classes and examinations shall be taken up in online mode as per the academic calendar uploaded on the Institute website.

2. Offices shall operate as per normal working hours and all employees shall attend the office daily in a staggered manner. A duty roaster may be prepared for the same by the concerned Head of Department/ Sections / Centers/ Central Facilities such that every employee attending office daily for at least one half of a working day.

3. Meetings and conferences shall be allowed with a maximum of 200 people at a time or 50%

seating capacity of the hall, whichever is lower.

4. The essential services like Institute Medical Unit/ Security/ Civil/ Electrical Maintenance/ Water supply/ Internet/ Telephone/ Cleaning/ Gardening services/ Food supply to hostels, Isolation ward and patients in home isolations etc. shall function as usual.

5. Students who are still in the hostels are allowed to continue to stay in the hostels and are

advised to take necessary safety precautions.

- 6. Individual care and precautions are also necessary. We should be 'Satark' and 'Saavdhan' and maintain a high level of vigil and alertness along with CoVID appropriate behaviour, like mandatorily wearing of masks within the NIT Durgapur campus. Our frontline staffs in health services, security, cleaning and others involved in different essential services should be more cautious.
- 7. Any misinformation and rumours should be avoided. Guidelines issued only by the authorised medium of Government of India should be followed.
